MOSCOW, ID—October 2, 2023—The Latah County Broadband Coalition will get another step closer to bridging the digital divide with new support. Starting in September 2023, a dedicated Digital Literacy Coordinator will help launch a County-wide digital inclusion effort.

University of Idaho Extension's Digital Economy Program (DEP) is placing AmeriCorps Members across the state to meet community members where they live and to deliver resources and training to empower Idahoans to participate in an increasingly digital society. Local resident, Kylie Holveck, will serve Latah County as a Digital Literacy Coordinator, working alongside the Latah Coalition, to improve digital access and opportunity in the County beginning with outreach and listening sessions to better understand barriers to digital access, especially among target populations.

"The county libraries' existing efforts to advance digital skills among the public will get a considerable boost from partnering with the Digital Literacy Coordinator," said Chris Sokol, director of the Latah County Library District. "Kylie is working with our Tech Help Team to identify new and exciting educational opportunities that we can provide for free to residents at all seven of our libraries throughout Latah County."

The <u>Digital Equity Act</u> recognizes eight target populations as disproportionately facing barriers to broadband internet access and adoption, including low-income households, aging populations, incarcerated individuals, veterans, individuals with disabilities, individuals with a language barrier, racial and ethnic minorities, and rural residents. Digital inclusion refers to the effort to ensure equitable access to and use of information technology by identifying and eliminating barriers to the tools and skills necessary to participate in an increasingly digital world.

"Broadband internet access and use is now an essential component to improving the quality of life for all Idahoans," says Amber Smyer, Program Manager for DEP. "We're thrilled to be able to place Kylie in Latah County to help leverage resources to expand digital access for individuals and rural communities.

The new coordinator will also add support to enhance Affordable Connectivity Program (ACP) awareness and increase enrollment. The \$14 billion ACP provides discounts for eligible households of up to \$30 per month toward broadband internet service and up to \$100 toward a one-time purchase of a computer, laptop, or tablet. Currently, fewer than 12% of eligible households in Latah County are receiving this benefit. Please visit the Latah County Broadband Coalition website for more information on ACP enrollment.

"Local Digital Literacy Coordinators like Kylie are crucial in improving digital access throughout Idaho," said Dylan Baker, Deputy State Librarian for the Idaho Commission for Libraries. "Latah County residents will benefit from this new support, helping them participate more fully in today's online and connected world."

It is administered by the Universal Service Administrative Company (USAC), an independent not-for-profit, with oversight from the FCC.
